## CALL FOR PROPOSALS 2016

Based on the needs of developing countries, the Japan Science and Technology Agency (JST) and Japan International Cooperation Agency (JICA) cooperate to promote international joint research targeting global issues\*1 with an objective of future utilization of research outcomes\*2. Implemented through collaboration with Official Development Assistance (ODA), the aim of the programme is to acquire new knowledge and technology that lead to the resolution of global issues and the advance of science and technology, and through this process, to create innovations. International joint research under this programme also aims to enhance the research and development capabilities of developing countries, and helps create sustainable research systems able to address and resolve development issues. In addition, the scheme will involve participation by the South African Department of Science and Technology (DST) insofar as it concerns the pre-selection and submission of project proposals to the Japanese funding agencies, in which regard the DST is pleased herewith to invite South African submissions by the closing date indicated below.

\*1 Global issues: Issues that are difficult to resolve by a single country or region acting on its own and that need to be handled by the international community as a whole.

\*2 Utilization of research outcomes: The research projects should lead to future social and economic benefits, achieved by using newly obtained technology and knowledge to enhance government services or to develop products that can be deployed in the market.

Proposals for FY2017 are invited in the following research fields: Environment/Energy (2 research areas), Bioresources (1 research area), Disaster Prevention and Mitigation (1 research area).

Interested researchers are requested to note the following:

- Only project proposals submitted in both countries will be considered for funding, thus necessitating prior coordination between the Japanese and South African applicants.
- Japanese applications should be submitted online at <u>www.e-rad.go.jp</u>
- South African applications should be submitted directly to the DST, to the coordinators provided below.

Only project proposals for research in the following themes and sub-themes will be considered for funding:

- Environment/Energy (2 areas)
- Bioresources (1 area)
- Disaster Prevention and Mitigation (1 area)

Up to FY2015, the SATREPS Invitation for Research Proposals included the Infectious Diseases Control field. From FY2016, projects in this field are handled by the Japan Agency for Medical Research and Development (AMED). Please visit AMED website new window for details regarding the invitation for research proposals in the Infectious Diseases Control field.

- Proposals submitted in South Africa will be subject to endorsement at government level, and subsequent recommendations for funding made to the Japanese authorities. However, the <u>final decision concerning funding will be made</u> <u>exclusively by the Japanese authorities</u>, and funding will only be accorded by the Japanese on a unilateral basis according to their own procedures and criteria.
- As a result of the unilateral nature of funding, the following information should be provided:
  - Full contact details of the applicant, including professional affiliation, race and gender
  - A detailed description of the project, including expected outcomes and significance of the research<sup>1</sup>
  - A detailed CV of the applicant, as well as an indication of previous collaborative activities undertaken between him/her and the Japanese counterpart
